## OVERVIEW

I study capitalism's evolution at the intersection of technology and organization, with a focus on how socially contested organizations affect the birth and renewal of industries (for a jargon-free overview, check [this](#) or [that](#) short piece, or this video [podcast](#)).

After researching international trade in the 17th century, analog & digital communications in the 1960s-90s, and the global arms industry around 9/11, JP's more recent research focus has been on decentralization.

These empirical settings all represent pivotal moments in the evolution of capitalism. My research on piracy led me to the hackers who, in the 1990s, developed open-source encryption software that later inspired the technology behind bitcoin. Much like the pirates of yore, crypto pioneers organize decentrally and seek to offer an alternative to an entrenched monopoly. Theoretically, my work contributes to related research on:

- (a) **Industry evolution & firm adaptation.** Explanations of evolution grounded in the notion of “path dependence” fall short of providing testable predictions (2013 [RP](#)). As an alternative, we offer a model of organizational adaptation that departs from simplistic analogies with biological organisms (2021 [JoM](#)). The model helps explain weapons firms' adaptive response to 9/11 (2016 [AMJ](#)).
- (b) **Categorization, stigmatization, and disapproval.** I've co-developed theory around “strategic categorization” (2014 [JMS](#)) to explain how firms associated with multiple industries (e.g., an arms company that also makes commercial aircraft) deal with stigma or media disapproval, and maintain an adaptive advantage over competitors (2012 [AMJ](#), 2015 [SMJ](#), 2026 [SMJ](#)). For better or worse.
- (c) **Organizational decentralization.** Categorization breaks down when highly decentralized organizing, as observable in Web3 (2020 [OTh](#)), blurs audience understanding of what organizations do and of who is in charge (2016 [RSO](#)). Decentralization, in turn, enables new industry models and new pathways for organizations to evolve (2023 [SMJ](#), 2024 [RSO](#), 2025 [JMS](#)).

I regularly collaborate with established firms, technology startups, and regulators around the above issues.

I'm not married to any particular method. I leverage field observations, interviews, econometric modeling of panel data, historical case studies, meta-analysis, and fuzzy-set qualitative comparative analysis (QCA).
